Healthcare and Seniors

Federal Employees

- Congress wants to cut retirement benefits for current and former federal workers by reducing the Cost of Living Allowance and eliminating Social Security supplements for FERS.
- Congress is not proposing a reduction to their retirement.

Environment & Our Future

- Climate control and the environment have taken a step backwards under President Trump.
- We need to invest in our planet and future by developing alternatives to fuel sources while controlling global warming.

My Background

- I grew up in a family with 5 children. My father was a fireman, and my mother worked for Sears.
- I have three children and my wife works for the Army and is a Veteran of the Gulf War
- I graduated from Temple University with a degree in Accounting and later earned an MBA from the University of Delaware.
- I worked 33 years for the Department of Defense. My federal service began at Aberdeen Proving Ground (APG), followed by positions in the Pentagon and later Columbus, Ohio as a Senior Executive Service member. I retired from APG in 2014.



- I managed over 3,000 people at 23 sites around the world, maintaining operations and reducing personnel. I eliminated waste and increased efficiency.
- I worked with Congress on budgets and legislation. I will bring this experience to Congress.
- I know first-hand the importance of healthcare for my family and others with preexisting conditions. I saw how my father struggled with paying Medicare payments as my mother spent her last days. Don't let Congress take away our health care.
