- I support renewable energy and incentives to go green.

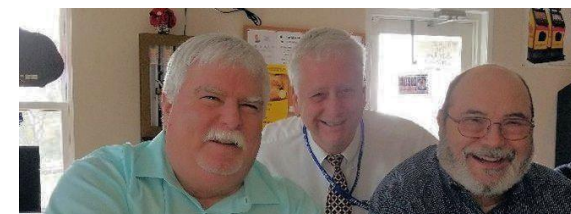


## Things to Consider
